To be eligible for the speech contest, candidates must be 16 or 17 years of age at the time of the tour, with a minimum of one year of high school remaining. Additionally, the tour requires a considerable amount of walking, so the delegates should be in good physical condition. While on the trip, they are required to participate in a speech contest while in New York for a chance to earn a \$2,000 1st place college scholarship, 2nd place \$1,000. The topic of that speech will be given to all delegates upon arrival in New York City. The dates for the tours will be departing on **June 29, 2024** and returning on **July 12, 2024**. Minnesota will send at least one delegate.
